1. I am over the age of 18 and I am responsible for the safety of any and all minors in my charge. I fully consent and agree for any minors in my care to participate in any activities provided by BCA 2. The risk of injury from activities involved with BCA is significant, including the potential for permanent paralysis and death, and while skills, equipment, and personal discipline may reduce the risk, the risk of serious injury does exist and, 3. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown including: head injuries, exposure to the natural elements, frostbite, hypothermia, sunburn, dehydration, heat exhaustion, heat stroke, and heat cramps; exposure to potentially dangerous wildlife, insects, plants; and accidental drowning is also a possibility. EVEN IF ARISING FROM THE NEGLIGENCE ON THE RELEASEES OR OTHERS, AND ASSUME FULL RESPONSIBILITY FOR MY PARTICIPATION; and, 4. I will agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual, significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of BCA immediately: and, 5. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release, indemnify, and hold harmless BCA, their officers, officials, agents and/or their employees, other participants, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and lessors of premises used for the activity ("Releasees"), from any and all claims, demands, losses, and liability arising out of or related to any injury, disability or death I may suffer, or loss or damage to person or property, whether arising from negligence of the releasees or otherwise, to the fullest extent permitted by law: and, 6. I understand that equipment must be returned in good condition. In the event of loss or damage, I agree to pay all repair or replacement costs, including legal fees incurred in the collection of said damages.
2. I have read this release of liability and assumption of risk agreement, fully understand its terms, understand that I have given up substantial rights by signing it, and sign it freely and voluntarily without an inducement.
3. I also agree that I and any minors in my care will always wear a personal flotation device/life jacket while on a watercraft. I agree that if I am participating in the surfing activities that I will not go beyond my physical abilities to put myself in danger. I agree that if a bicycle is involved, a helmet will always be worn. While BCA may assist in mounting gear on vehicles, responsibility for ensuring all mounts are secure and safe is my sole responsibility.
